NOTICE OF PUBLIC HEARING ON TAX INCREASE

This notice only applies to a taxing unit other than a special taxing unit or municipality with a population of less than 30,000, regardless of whether it is a special taxing unit.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for CENTRAL TEXAS COLLEGE from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval tax rate is the highest tax rate that CENTRAL TEXAS COLLEGE may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CENTRAL TEXAS COLLEGE is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON 09/17/2024 12:30 PM (CT) at Central Texas College, Anderson Campus Board Room, 6200 W Central Texas Expressway, Killeen, TX

The proposed tax rate is not greater than the voter-approval tax rate. As a result, CENTRAL TEXAS COLLEGE is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Central Texas College Board of Trustees of CENTRAL TEXAS COLLEGE at their offices or by attending the public hearing mentioned above.
