REFERENCE LIST:

Reference or **References** is centered bolded at the top of its own page. Sources are in hanging paragraph format. List sources in alphabetical order by the author's last name or by title if there is not an author.

Book and Article Titles only the first word of the title, subtitle and proper nouns are capitalized. Article titles are not enclosed in quote marks.

Books-EBooks

Journal Article - Print

MULTIPLE AUTHORS:

Two to Twenty Authors List each author's last name, initials separated by commas. Proceed the last author's name with an ampersand "&."

More Than Twenty Authors List the first 19 authors' last names and initials. Use ellipses ... in place of the remaining names. Give Last author's name after the ellipses.

Note: The "&" is not used.

CORPORATE / GOVERNMENT / AGENCY AUTHOR

Book

Corporation's Name. (Year). *Title of the book:* Subtitle of the book, (Edition). Publisher. Provide the DOI or URL if published electronically

Journal

Corporation's Name (Year). Title of the article: Subtitle of the article. *Title of the Journal, volume number* (issue number), page range. DOI

NO AUTHOR

Note: For alphabetical purposes, ignore initial articles: "The", "A", and "An".

Book

Title of the book: Subtitle of the book,
(Edition). Publisher. [NOTE: Provide the DOI or URL if published online]

Article

Title of the article: Subtitle of the article.

Title of the Journal, volume number (issue number), page range. DOI or URL

NO PUBLICATION DATE

Use the letters n.d. for the year.

FORMATTING & IN-TEXT CITATIONS

FONT: Accessible to all users. Font options and sizes: Calibri-11, Arial-11, Times New Roman-12, Georgia-11. Same font is used throughout.

LINE SPACING: Double throughout.

COVER PAGE:

Header: Page Number only, flush with right margin.

Title: Bold, centered, positioned 3-4 double spaced lines down from the top margin. Initial letters of the title are capitalized.

Student's Name: Should be 1 double spaced line below the title, centered, and in regular font.

Rest of the paper is double spaced.

ABSTRACT: If required, is on the second page.

Title of the Paper

Abstract

The abstract summarizes the ideas presented and defines any acronyms and abbreviations in the paper. It is flush with the left margin, double spaced, and no more than 250 words. The keywords are indented ½ inch in from the left margin. Keywords is italicized and followed by a colon.

Keywords: ideas, paper, paragraph

Title of the Paper

Indent the 1st line of each new paragraph. Paper's text is double spaced. There are not any blank lines between paragraphs.

IN-TEXT CITATIONS FORMAT: PARAPHRASES & SUMMARIES

PARENTHETICAL [P]: Placed at the end of a sentence, before the period.

NARRATIVE [N]: Author's Last Name used in the body of a sentence, followed by the Year enclosed in parentheses.

One Author

[P]: (Author's Last Name, Publication Year)

[N]: Author's Last Name (Publication Year) text of the sentence.

Two Authors

[P]: (1st Author's Last Name & 2nd Author's Last Name, Publication Year)

[N]: 1st Author's Last Name and 2nd Author's Last Name (Publication Year) text of the sentence.

Three or More Authors

[P]: (1st Author's Last Name et al., Publication Year)

[N]: 1st Author's Last Name et al. (Publication Year) text of the sentence.

No Author

If the title is long, shorten it for the in-text citation. Capitalize initial letters of titles. NOTE: APA manual does not show examples for title narrative in-text citations.

- Books Italicize the Book's Title. [P]: (Book's Title, Publication Year).
- Article- The "Article's Title" is in quotes. **[P]:** ("Article's Title," Publication Year).

CORPORATE / GOVERNMENT / AGENCY AUTHOR

FONT: For parenthetical citations, enclose the acronym in square brackets. For narrative citations, use parentheses.

Subsequent in-text citations, use the agency's acronym

[P1]: (Acronym, Publication Year).

[N2]: Aconym (Year) text of the sentence.

DIRECT QUOTES WITH PAGE NUMBERS.

When quoting directly always provide the author's last name, the publication year, and page number.

[P]: (Author's Last Name, Publication Year, p. number).

[N]: Author's Last Name (Publication Year) text of the sentence (p. number).

DIRECT QUOTES WITHOUT PAGE NUMBERS

When page numbers are not available, provide alternative location information - e.g. paragraph number (para. #), section name or number (sec. #).

[P]: (Author's Last Name, Publication Year, para. number).

[N]: Author's Last Name (Publication Year) text of the sentence (para. number).
